ALL EXHIBITS MUST BE IN THEIR PLACE NO LATER THAN 12.30PM. FRIDAY 10 May.

Exhibit Requirements:

500g Standard round glass jars with white lids.

Full depth frame of Honey.

APICULTURE:

To expediate judging, jars should not be filled to capacity, but have an air space of 6mm left at the top of the jar.

Unless otherwise stated, all exhibits in this section must be the property of and the produce of the exhibitor's own apiary or apiaries.

THE EXHIBITORS NAME MUST NOT APPEAR ON ANY EXHIBIT.

Multiple entries from an exhibitor in any one class, it is essential that individual exhibit be derived from a different FLORAL source.

Where in the opinion of the judge, an entry is entered in a wrong class, the Judge may refer the matter to the Steward for inquiry and upon the recommendation of the Judge and at the discretion of the Steward, such an entry may be transferred to the class for which it is eligible.

Class 1 – 2 jars liquid honey – WHITE (0-34 Pfund Honey colour Grader Range)

Class 2 – 2 jars liquid honey – LIGHT AMBER (35-65 Pfund Honey colour Grader Range)

Class 3 – 2 jars liquid honey – GOLDEN (66-90 Pfund Honey colour Grader Range)

Class 4 – 2 jars liquid honey – DARK (910120 Pfund Honey colour Grader Range)

Class 5 – 2 jars granulated honey – FINE GRAIN

Class 6 – 2 jars granulated honey – COARSE GRAIN

Class 7 – 2 jars creamed honey

Class 8 – 2 jars comb and liquid honey

NOVICE SECTION – No entry Fee. **Prize:** 1st \$3.00, 2nd \$2.00

Class 9 – 2 jars liquid honey – WHITE (0-34 Pfund Honey colour Grader Range)

Class 10 – 2 jars liquid honey – LIGHT AMBER (35-65 Pfund Honey Colour Grader Range)

Class 11 – 2 jars liquid honey – GOLDEN (66-90 Pfund Honey colour Grader Range)

Class 12 – 2 jars liquid honey – DARK (910-120 Pfund Honey colour Grader Range)

CHAMPION HONEY OF THE SHOW. RESERVE CHAMPION HONEY OF SHOW.

(Selected from Apiculture classes 1 - 12)

POLLEN: **Entry Fee** \$1.00. **Prize money** 1st \$3.00, 2nd \$2.00.

Class 13 – 2 jars pollen, cleaned and dried.

COMB HONEY: **Entry Fee** \$1.00. **Prize money** 1st \$3.00, 2nd \$2.00.

Cut comb and the frame of honey in class 14 and 15 must be free of paper and decorative borders, so that all the comb surfaces can be judged. Frames to be exhibited in a single frame observatory hive, painted gloss white.

Class 14 – Two sections of cut comb, each not less than 250g (normal weight) of uniform size.

Class 15 – Frame of comb honey, any size.

CHAMPION BEST COMB FROM SECTION 14 AND 15 Prize \$10.00

BEESWAX: **Entry Fee** \$2.00. **Prize money** 1st \$6.00, 2nd \$4.00.

Class 16 – White Beeswax, not less than 1 kg in one block.

Class 17 – Yellow Beeswax not less than 1kg in one block.

Class 18 – Beeswax, minimum display of five tablets. Total weight minimum of 1 kg.

BEESWAX DISPLAY OF MOULDED OR SCULPTURED FORM:

Entry Fee \$4.00. **Prize money** 1st 12.00, 2nd \$8.00.

Class 19 - This display can be coloured beeswax of not less than 3kg in total weight. This display must be beeswax and not other material can be used. The colour, attractiveness and arrangement will be considered. The display base must be confined to the base area of 500mm X 500mm and be no more than 500 mm high. Maximum number of items in display to be no more than 20.

PRODUCT OF HIVE DISPLAY: **Entry Fee** \$4.00. **Prize money** 1st 12.00, 2nd \$8.00.

Class 20 – Maximum number of items to be displayed not more than 20 items.

SPECIAL RULES AND REGULATIONS.

The Marburg & District A. & I. Association Inc.'s Annual Show will be held under the Rules and Regulations of the Queensland Chamber of Agricultural Societies (Q.C.A.S.). **All Exhibitors attending the Show are to pay Admission Fees.** The Marburg and District A. & I. Association Inc. assumes no responsibility for injury or damage to the person, property or stock of any owner, contestant, exhibitor or assistant. Each participant, by the act of his/her entry, waives all claim against the Association for injuries he/she or his/her property may sustain or that his/her animal may cause. All persons enter the Show Ring at their own risk. Small children and persons who, by their actions, present a risk to themselves or others will be directed, by the Stewards, to leave the Ring. Baby's prams/strollers are **not allowed** to enter the Show Ring.

ELECTRICAL SAFETY ACT 2002 - Any exhibitors or persons attending the Show must ensure they comply with the provisions of these Acts. Any exhibitors intending to bring electrical equipment to the Showgrounds will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor and have a current tag attached. This is essential for the safety of all exhibitors and the general public. This is a requirement under the provisions of the Electrical Safety Act 2002 and Marburg District Agricultural and Industrial Association Inc. The Act imposes very severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Marburg Show Grounds. Exhibitors should check all electrical equipment and leads before coming to the Showgrounds to avoid the occurrence of any difficulties. If necessary, a certified electrician will be on the grounds to carry out an inspection and tagging, however, there will be a charge for this service.

WORKPLACE HEALTH AND SAFETY ACT 1995 - NO MOVEMENT OF VEHICLES THROUGH THE GROUNDS BETWEEN 9.00A.M. AND 8.00P.M., excepting Ambulance or Emergency Vehicles. Patrons/exhibitors must park vehicles at the park in Main Street, Marburg or on Queen Street if they can find a park, as there is limited areas for parking away from where the public walk.

First Gate entrance into Marburg Show Grounds – Judges and into the Disabled Parking Area, Only.

Second Gate – General entry:

Third Gate entrance into Marburg Show Grounds – is for horse entrants. They park up on the hill and at the back of the grounds, as they need to tie their horses to their floats.

PAVILIONS:

Pavilion Exhibits must be in the hands of the Stewards as directed under the heading of each Section. Exhibits **MUST NOT BE REMOVED** before 7.30p.m. on the Saturday of the Show. Collection is on Sunday Morning between 10.00 a.m. and 12.00p.m.

All persons exhibiting must accept the decision of the Judges appointed by the Committee, and on all protests the decision of the Committee shall be final without appeal, provided that the exhibitor shall have the right of appealing against disqualification imposed as provided for in the Constitution of the Queensland Chamber of Agricultural Societies. No protest will be considered unless it is presented to the Secretary, in writing with the PROTEST FEE \$50.00, which may be forfeited should the Committee consider the protest frivolous. Any person or persons interfering with a Judge, or who shall be guilty of unseemly conduct to a Judge or Steward or Official of the Association, or any exhibitors refusing in any way to carry out the instructions of a Steward, shall be liable, at the discretion of the Committee, to a penalty not exceeding \$50.00, or otherwise, may be disqualified from exhibiting for any period, or may be expelled from the grounds, together with his/her or their exhibits. The Association reserves the right to alter the time or order of an event. The Association reserves the right to refuse any nomination by any exhibitor without reason. The Committee reserves the right to cancel or reduce the prize money through lack of competition.

Any exhibit entered in the wrong class must be transferred to the right class at the discretion of the Judge. A Judge shall not have any information prior to or during judging at an agricultural Show other than what is provided by the Marburg Show Association only.

All prizes awarded at the Show must be collected on the day or as soon as possible in cases where there is a protest. All prizes not collected will be forfeited to the Association. Prize- winners of over \$50.00 - (Forms available at Show Sec.'s office) G.S.T. registered prize- winners claim G.S.T. on prize money by issuing a Tax Invoice including A.B.N. OR Hobbyists form must be filled in OR 48.5% will be withheld. A Copy of these rules may be seen at Secretary's Office.
